- Booking fee of R15 000 is payable to confirm date and all vendors.
 - There is a set budget allocated to each vendor. You can however still add extra services with the vendors for your own account.
 - The full amount is payable to De La Mas, any extra services booked can be paid directly to the vendor involved.
 - Final payment must be made 30 days before wedding.
 - If a vendor that is part of this package is unavailable, De La Mas will provide you with a substitute service provider of the same quality.
 - No vendor can be cancelled/replaced by client.
 - **Once booking is confirmed, all vendors will get in contact with you.**
 - Additional guests catering will be charged extra at R470 per person.
 - The package is for 70 guests. If couple don't make the quota, no discount will be granted.

- De La Mas reserves the right of admission.
 - No smoking inside building. Only outside. No fireworks.
 - No alcohol not purchased at De La Mas bar will be permitted on the premises. Penalty of R2000 will be implemented.
- This includes bridal suite, man cave and parking area.
- No alcohol to be used as guest gift or wedding cake.
 - De La Mas, its staff, or any person employed for a function will not be held liable for any loss or injury as a result of neglecting or any other case.
 - Children should be supervised by adults at all times.
 - A breakage deposit of R3000 will be added on your invoice and refunded 14 days after wedding.
 - Any damage or theft by bridal couple or guest to De La Mas venue will be deducted from the breakage deposit or invoiced.
 - Reception hall closes at 24:00
 - Over-time rate after 7 hours included in package:
 - o R2500 per hour for reception area,
 - o R1000 per hour for boma area
 - o Overtime must be paid in cash on the night of the wedding. If paying by card a 3% transaction fee will be added.
 - Bar will be closing at 24:00, no exceptions. De La Mas reserves the right to close the bar at any time should there be any irregularities on the guest's behalf.
 - Guests are not permitted in the bar or kitchen.
 - Bar prices are subject to change without prior notice.
 - Bar tabs not paid by guests, will be invoiced.
 - Up to 3 appointments is free of charge. Thereafter a fee will be charged.
 - 1 Final consultation 2-3 weeks before wedding. In the event of non-payment of fees, we will not be able to schedule meeting.
 - Clean up/collection the next day from 09:00-10:00. Overtime will be charged at R200 per hour for cleanup.
 - Please do respect our business hours at all times.
 - The entire venue is used at own risk.
